FUND MANAGER COMMENTS

Annual inflation declined to 3.4% in February. The Bank of England maintained its base rate at 5.25%. Meanwhile, a final reading confirmed that UK GDP contracted by 0.3% in the last quarter of 2023, meaning that there was a technical recession. The Manufacturing Purchasing Managers' Index rose from 47.5 in February to 50.3 in March. In markets, SONIA remained unchanged at 5.19%, the 2-year gilt yield declined from 4.28% to 4.16% and the 5-year gilt yield decreased from 4.04% to 3.82%. We bought certificates of deposit and commercial paper from ING, ABN Ambro, Bank of Montreal, BFCM, Nordea, TD Bank, Bank of America, UBS, United Overseas Bank, First Abu Dhabi Bank and SEB, among others. We bought floating-rate notes from ANZ. The weighted average maturity of the Fund was 44 days at the end of February and 45 days at the end of March.

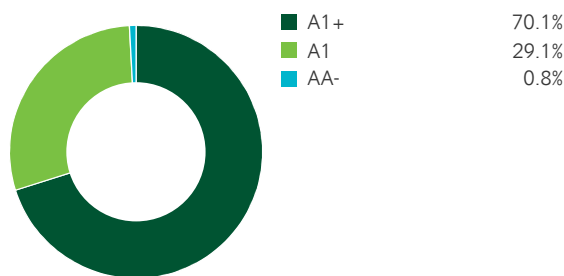

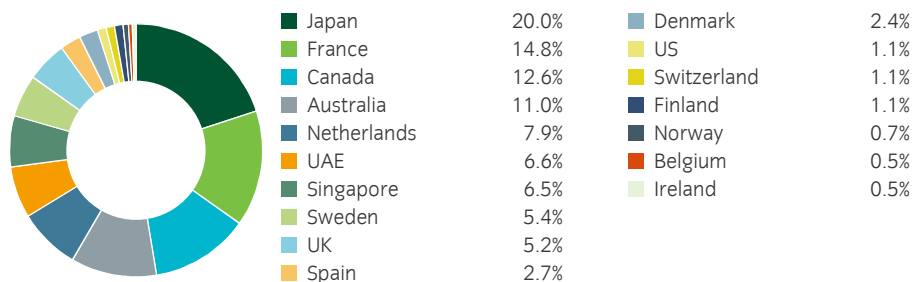

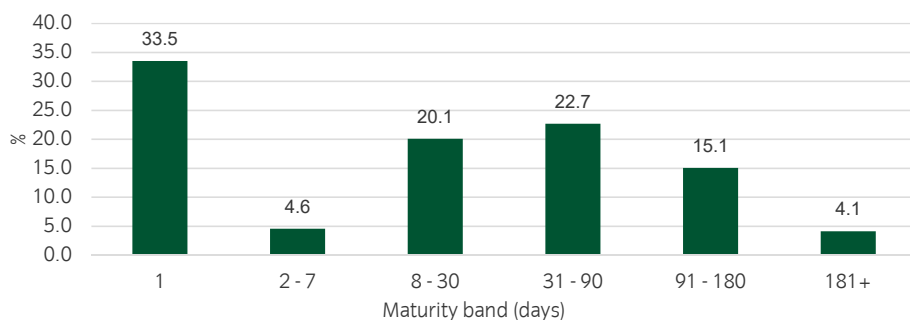

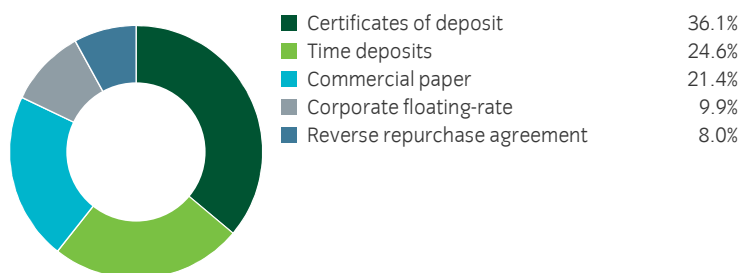
GEOGRAPHY
