## FUND MANAGER COMMENTS

The Bank of England cut the Bank Rate by 25bp to 5% in August. This was the first interest rate cut since March 2020. Annual inflation rose by 20bp to 2.2% in July, as gas and electricity prices moderated. The economy expanded by 0.6% in the second quarter according to a preliminary estimate, marginally lower than the 0.7% growth rate recorded in the previous quarter. The Manufacturing Purchasing Managers' Index rose from 52.1 in July to 52.5 in August. In markets, SONIA fell from 5.20% to 4.95%, the 2-year gilt yield rose from 3.70% to 3.72% and the 5-year gilt yield increased from 3.67% to 3.92%. We bought certificates of deposit and commercial paper from BNG, Barclays, DNB, Nordea, Deka and Rabobank. We bought bonds and floating-rate notes from Kommunalbanken. The weighted average maturity of the Fund was 40 days in July and 41 days at the end of August.

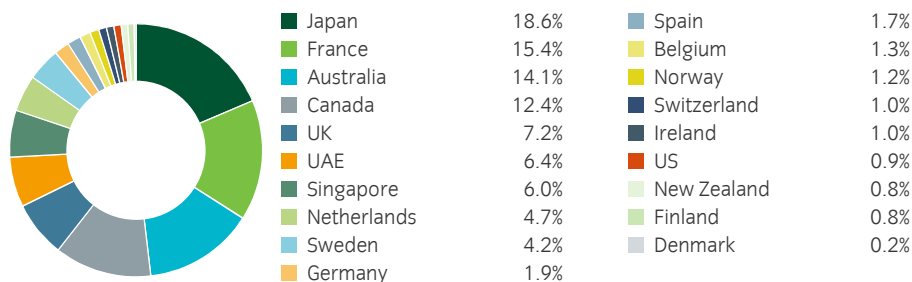

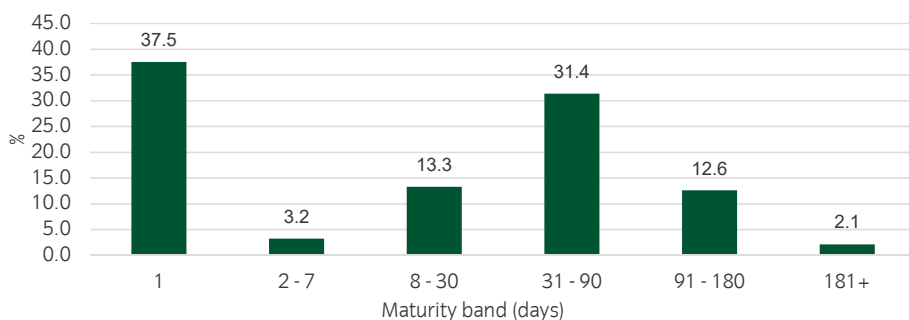

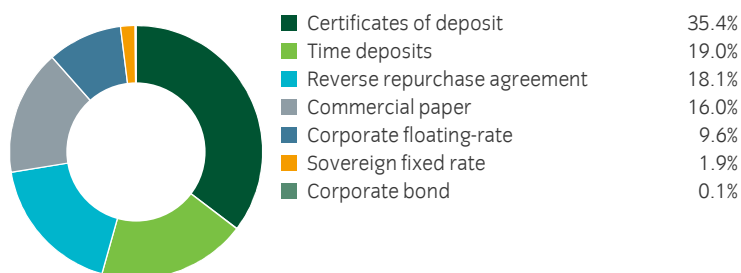
