FUND MANAGER COMMENTS

The Bank of England cut the Bank Rate by 25bp to 4.25% at the start of the month. However, three weeks' later it was announced that annual inflation had risen from 2.6% in March to 3.5% in April, driven by a sharp annual increase in gas, electricity and water costs. The economy expanded by 0.7% in the first quarter of the year according to a preliminary estimate compared to 0.1% Q4, 2024. In markets, SONIA decreased from 4.45% to 4.21%, the 2-year gilt yield rose from 3.80% to 4.03% and the 5-year gilt yield increased from 3.92% to 4.14%. We bought certificates of deposit and commercial paper from First Abu Dhabi Bank, United Overseas Bank, KBC Bank, DZ Bank, ING, Jyske Bank and Transport for London. We bought floating-rate notes issued by Bank of Montreal.

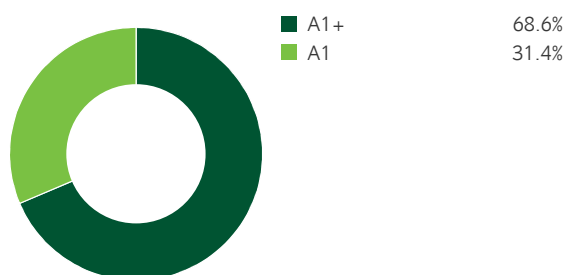

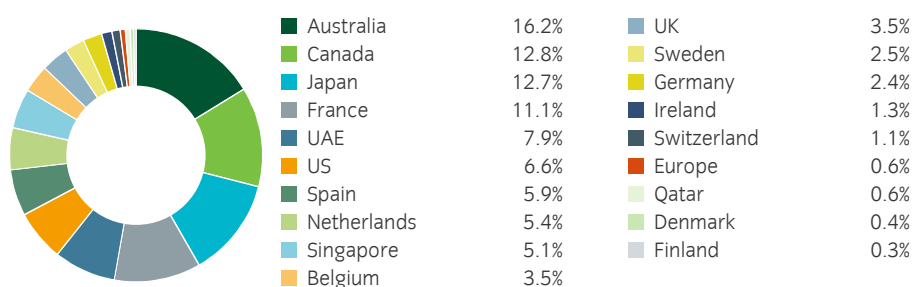

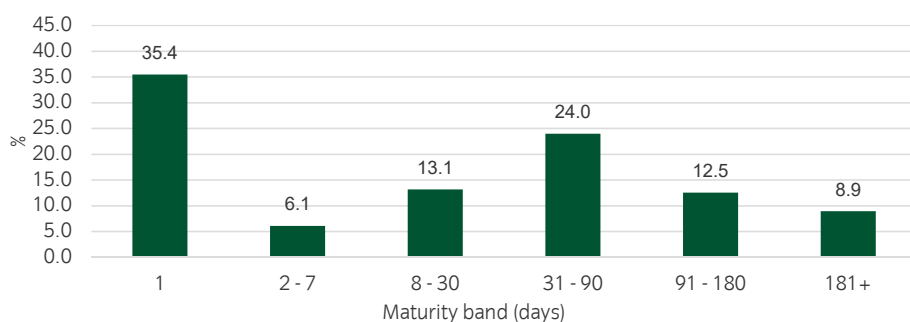

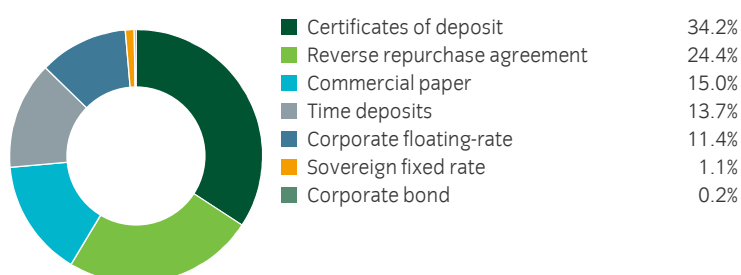
GEOGRAPHY
