FUND MANAGER COMMENTS

The US annual inflation rate was unchanged at 3.7% in September, with a reduced fall in energy costs offsetting a slower pace of other price rises. The US economy expanded at an annualised rate of 4.9% in the third quarter, led by consumer spending growth of 4%. The manufacturing purchasing managers' index rose to 50 in October from 49.8 in the prior month. In markets, the Secured Overnight Financing Rate rose from 5.31% to 5.35%. Fund activity was centred around positioning for central bank meetings. The weighted average maturity of the Fund was 22 days at the end of September and 21 days at the end of October.

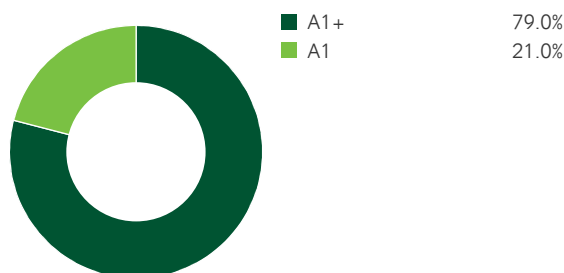

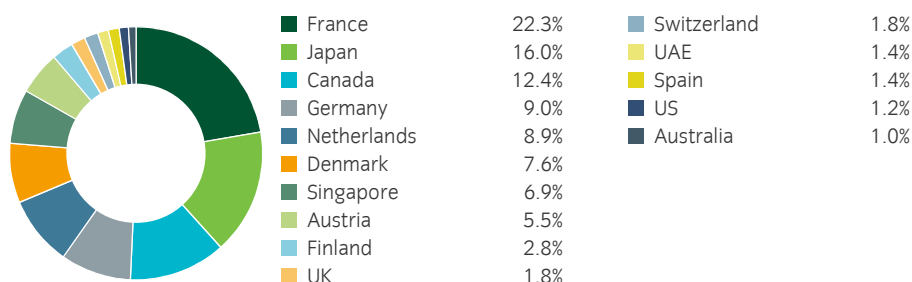

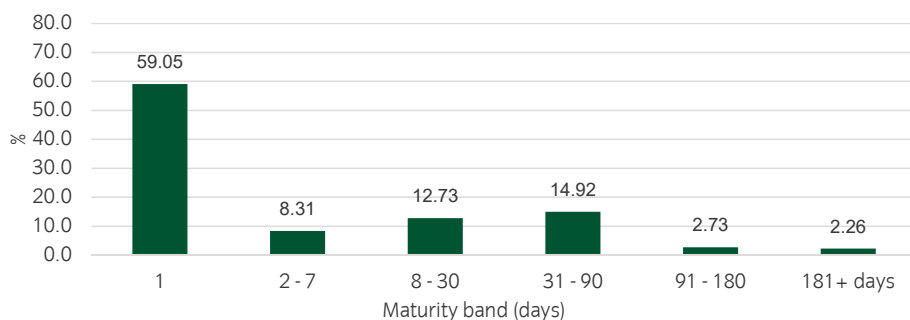

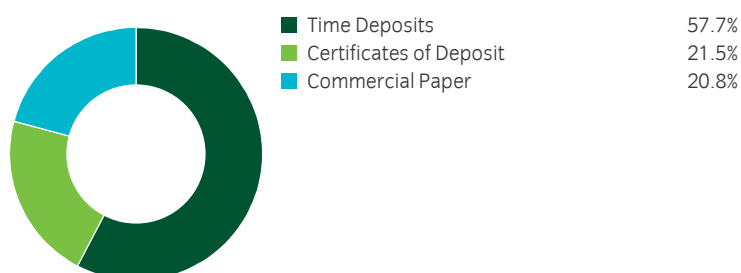
GEOGRAPHY
