FUND MANAGER COMMENTS

Annual inflation declined by 10bp to 3.1% in November, due to a fall in energy costs. The US Federal Reserve maintained the target range for the fed funds rate at 5.25-5.50% at its December meeting. Annualised third quarter GDP growth was downgraded by 30bp to 4.9%. The manufacturing purchasing managers' index declined from 49.4 in November to 48.2 in December. In markets, the Secured Overnight Financing Rate rose marginally from 5.33% to 5.38%. While the inflation outlook appears positive and markets are pricing no further rate hikes, selective term investments were favoured, especially over year end. Positioning will be determined by upcoming central bank meetings. The weighted average maturity of the Fund was 18 days at the end of November and 21 days at the end of December.

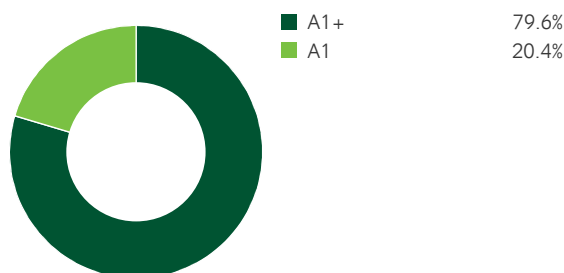

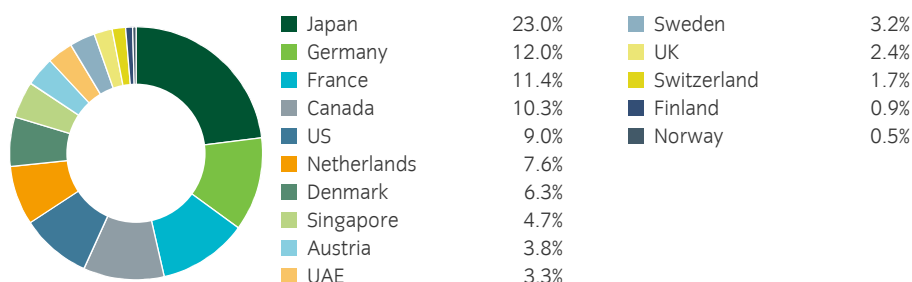

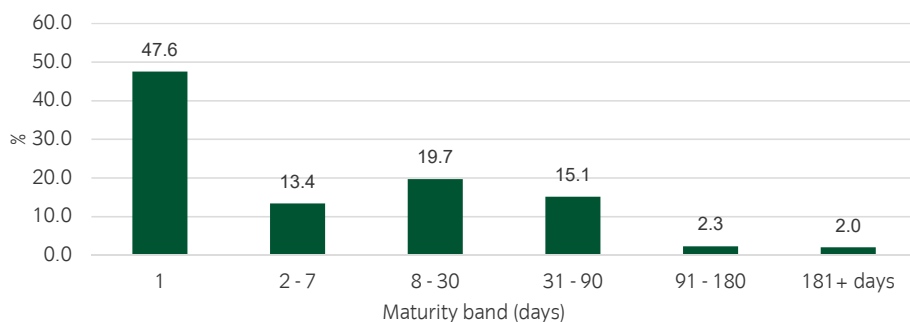

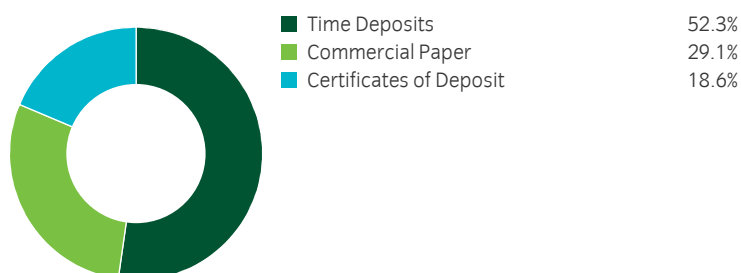
GEOGRAPHY
