FUND MANAGER COMMENTS

Annual inflation rose by 30 basis points to 3.4% in December. Although energy prices continued to fall, their rate of decline moderated. The US Federal Reserve left the target range for the fed funds rate unchanged at a 23-year-high of 5.25-5.5% at its January meeting. The economy grew at an annualised rate of 3.3% in the fourth quarter of 2023, according to an advance estimate. The Manufacturing PMI rose from 47.9 in December to 50.7 in January, which was its highest reading since September 2022. In markets, the Secured Overnight Financing Rate declined from 5.38% to 5.32%. While the inflation outlook appears positive and markets are pricing in no further rate hikes, selective term investments were favoured. Positioning will be determined by upcoming central bank meetings. The weighted average maturity of the Fund was 21 days at the end of December and 24 days at the end of January.

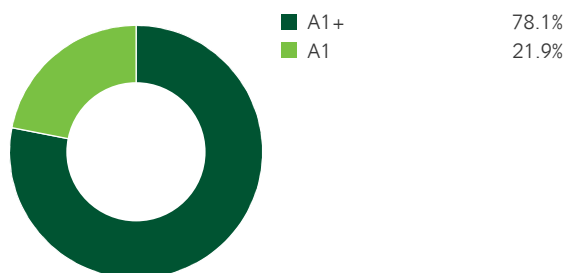

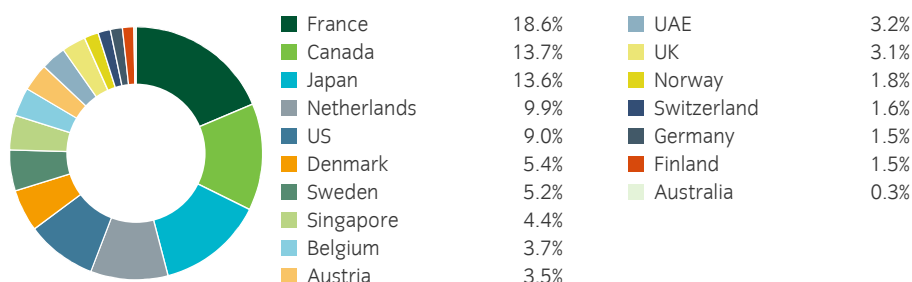

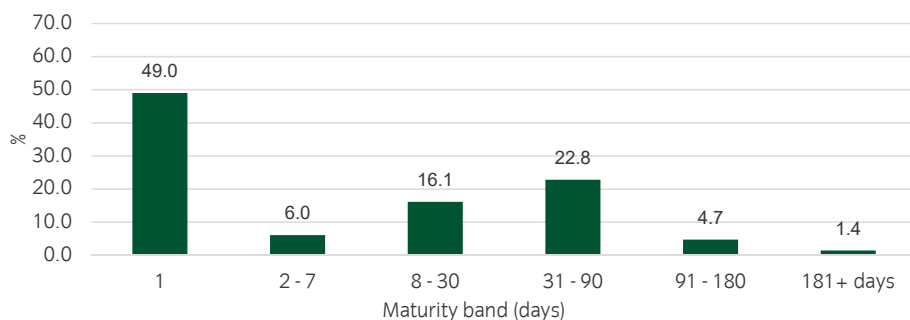

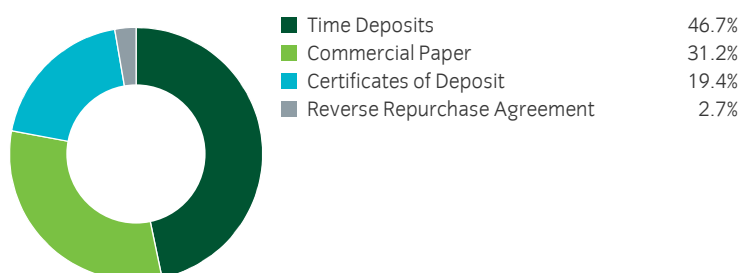
GEOGRAPHY
