## FUND MANAGER COMMENTS

The US Federal Reserve left the target range for the federal funds rate unchanged at 4.25%–4.50% in March. This announcement came a week after it was announced that annual inflation had declined from 3.0% in January to 2.8% in February. According to a final reading, the economy grew at an annualised rate of 2.4% in the last quarter of 2024, which was a slowdown from the 3.1% rate recorded in the third quarter. The Manufacturing Purchasing Managers' Index declined from 52.7 in February to 50.2 in March, while the Services Purchasing Managers' Index rose from 51.0 in February to 54.4 in March. In markets, the Secured Overnight Financing Rate rose marginally from 4.39% to 4.41%. Positioning will be determined by central bank meetings.

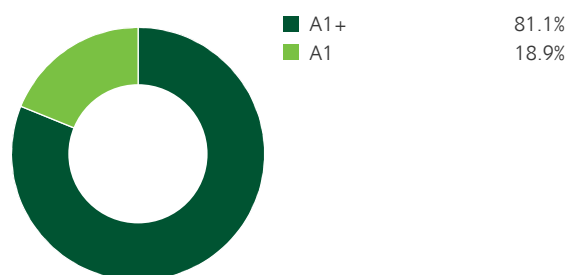

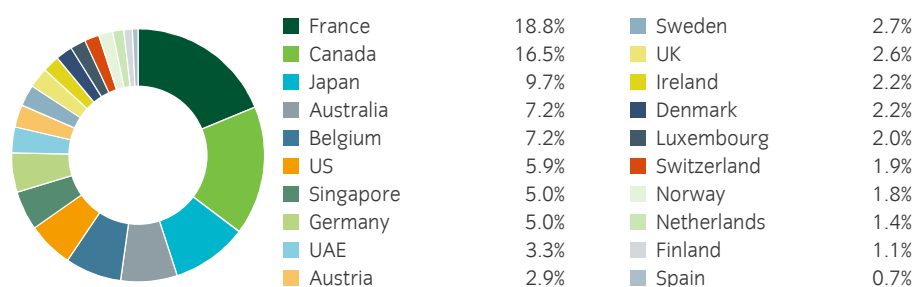

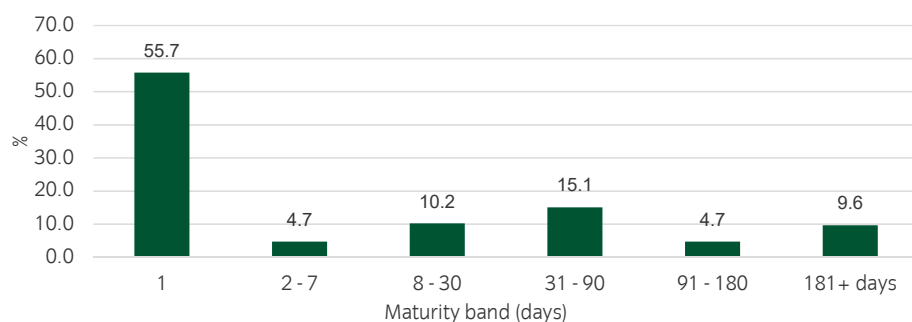

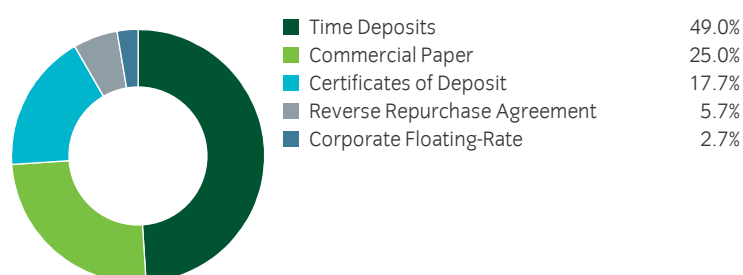
