
FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in January, ending with a running yield of 131bp over SONIA and a 75% weighting to AAA rated assets. Risk assets experienced volatility, as investors priced in delayed rate cuts. European structured credit performed well. Higher beta classes outperformed again. Our positions in AA-rated collateralised loan obligations (CLOs) and non-conforming (NC) UK residential mortgage-backed securities (MBS) performed well. Investors absorbed robust supply across several sectors and jurisdictions, with UK prime issuers coming back to the market. US structured credit posted gains, against record issuance and very strong demand. Many deals were 5-10 times oversubscribed. In the secondary market, spreads notably tightened in investment grade A and BBB rated paper and within the subprime automotive sector. We see value in US middle market CLOs. Performance was broad-based, with CLOs, UK NC residential MBS and commercial MBS contributing most strongly.




