FUND MANAGER COMMENTS


The Fund underperformed its cash benchmark in March, ending with a running yield of 119bp ahead of one-month SONIA and a 99% weighting to AAA-rated assets. Risk assets had a volatile month due to the turmoil in the banking sector. European structured credit saw robust performance, although it was characterised by significant dispersion. Residential mortgage-backed securities (RMBS) and asset-backed securities performed well due to strong technical conditions, while collateralised loan obligations (CLOs) and commercial mortgage-backed securities declined significantly. March saw subdued issuance in Europe. US structured credit was mixed, as strong new issuance at the start of the month retracted after the banking crisis caused market volatility. March was quiet on the lending side. A broad-based appreciation in asset prices drove performance, with prime RMBS, automotive credit *and* CLOs contributing most strongly. We deployed capital into new issues and secondary bonds.




