FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in July, ending with a running yield of 99bp ahead of one-month SONIA and a 99% weighting to AAA-rated assets. Risk assets posted gains, due to a narrative embracing moderating inflation. In contrast, government bonds declined, owing to further monetary tightening from major central banks and continued issuance of longer-dated bonds. European structured credit performed well, against a strong technical backdrop and constrained supply. European collateralised loan obligations outperformed their US counterparts. We saw weaker performance in the legacy UK non-conforming market. July saw strong issuance across Europe and Australian residential mortgage-backed securities. US structured credit moved higher, despite elevated supply. Spreads across prime automotive loans and other sectors tightened. Prime residential mortgage-backed securities and automotive issuers contributed most strongly to performance. We were opportunistic in our purchases.




