FUND MANAGER COMMENTS


The Fund outperformed its cash benchmark in December, ending with a running yield of 93bp ahead of one-month SONIA and a 99% weighting to AAA rated assets. Risk assets rallied on hopes of a soft landing and rate cuts in 2024. European structured credit performed well. Higher beta classes outperformed but the senior market also posted gains. Demand outweighed thin supply, aiding the technical backdrop. It was a quiet month for issuance, in line with the seasonal pattern. US structured credit posted gains, against limited supply and strong demand in secondary markets. Higher beta sectors, including commercial mortgage-backed securities (MBS), outperformed, as concerns around financing costs subsided. Performance was broad-based, with residential MBS contributing most strongly. Our outlook for asset-backed securities remains positive, due to robust technicals, dovish central bank signals and attractive valuations relative to corporate credit.






