FUND OBJECTIVE

The Fund seeks to generate a return for investors mainly through investment in a portfolio of liquid asset backed securities (ABS) and corporate floating rate notes (FRNs)

FUND MANAGER COMMENTS

The Fund was behind its cash benchmark in March, with an average rating of AAA, while remaining ahead year to date. Financial markets weakened through March, with risk assets coming under pressure as the escalation of the Iran conflict weighed on sentiment. Credit spreads moved wider, particularly in lower-quality segments, as investors de-risked amid higher volatility and reduced liquidity. European ABS remained comparatively resilient despite the broader risk-off tone, supported by consistent demand for high-quality, shorter-duration paper, with senior risk outperforming mezzanine tranches. US ABS markets were also pressured, with issuance slowing and spreads widening across the capital structure as investors reassessed expectations around the length and severity of the conflict, although spread widening remained broadly orderly. New issue activity slowed during the month given uncertainty around oil markets, with spread widening more pronounced lower down the capital structure. The Fund rotated into more attractive securities from a risk-return perspective and selectively crystallised profits accumulated since acquisition, benefiting from the short-dated nature of positions despite heightened volatility.

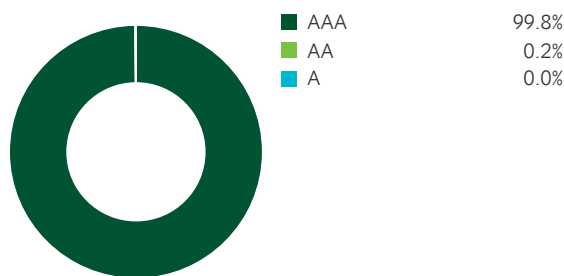

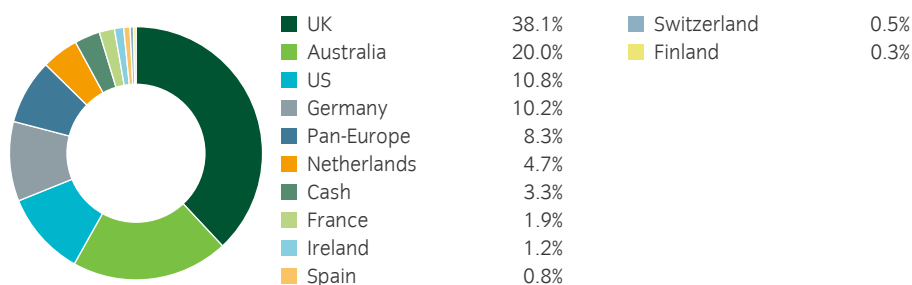

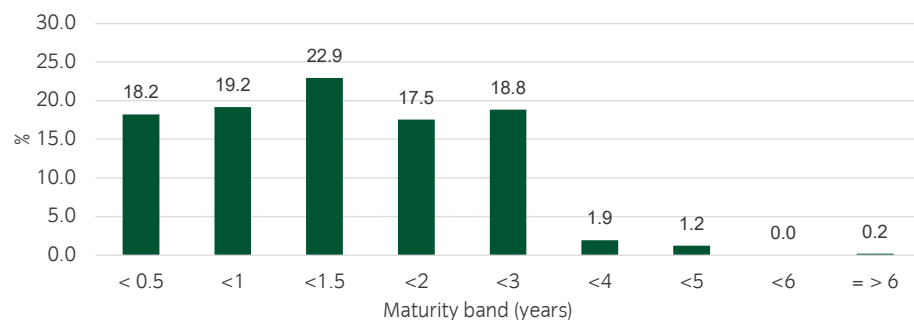

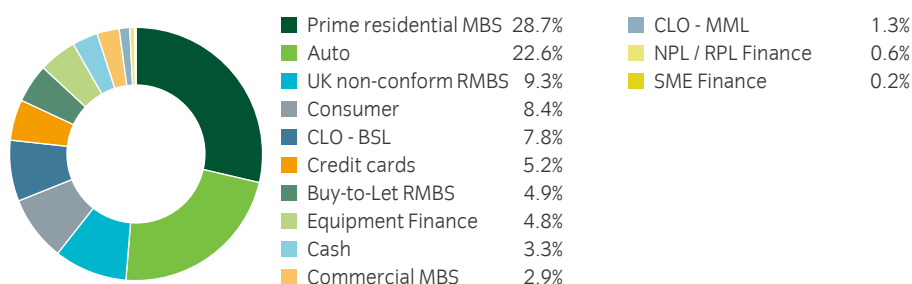
