## FUND OBJECTIVE

The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

- Actively managed to aim to deliver security, liquidity and attractive cash yields comparable to short-dated money market interest rates
- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks

## FUND MANAGER COMMENTS

Annual inflation increased to 4% in December. The 10bp rise was mainly due to a faster rate of growth in alcohol and tobacco prices. The Manufacturing Purchasing Managers' Index (PMI) rose from 46.2 in December to 47.0 in January, while the Services PMI increased from 53.4 to 54.3 over the same period. In markets, SONIA remained unchanged at 5.19%, the 2-year gilt yield rose from 3.96% to 4.25% and the 5-year gilt yield increased from 3.56% to 3.76. While the inflation outlook appears positive and markets are pricing in no further rate hikes, selective term investments were favoured. Positioning will be determined by upcoming central bank meetings. The weighted average maturity of the Fund was 24 days at the end of December and 23 days at the end of January.

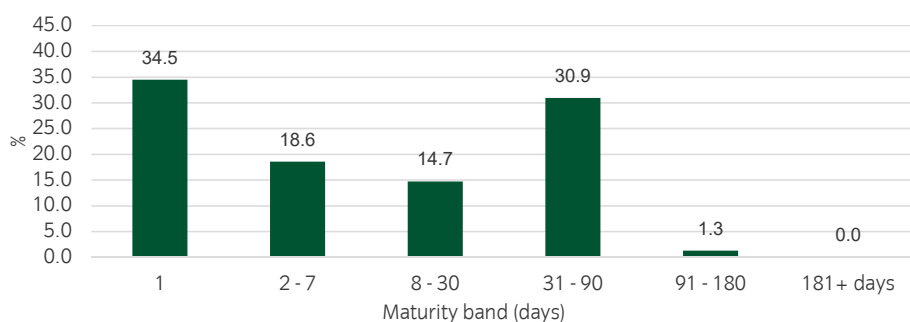

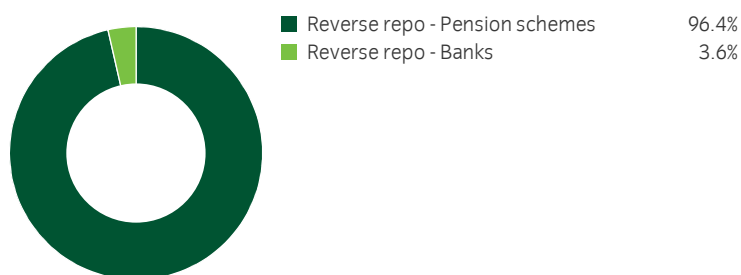
