FUND MANAGER COMMENTS

The US annual inflation rate increased by 50 basis points to 3.7% in August, with higher oil prices being a key contributor. The US Federal Reserve left the target range for the fed funds rate unchanged at 5.25-5.50% at its September meeting. Annualised GDP growth in the second quarter was confirmed at 2.1%, according to a final estimate. The manufacturing purchasing managers' index increased to 49.8 in September, from 47.9 in August, as the pace of decline in new orders slowed. In markets, the Secured Overnight Financing Rate remained unchanged at 5.31%. Fund activity was centred around positioning for central bank meetings. We will continue to position for further central bank rate hikes, with risks around the stickiness of inflation. The weighted average maturity of the Fund was 22 days at the end of August and 22 days at the end of September.

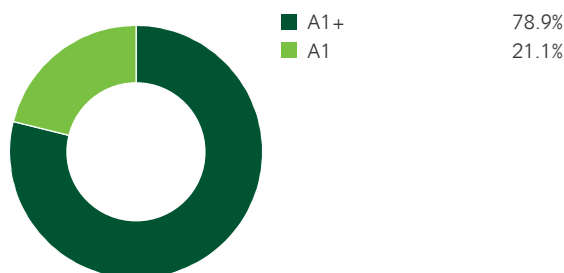

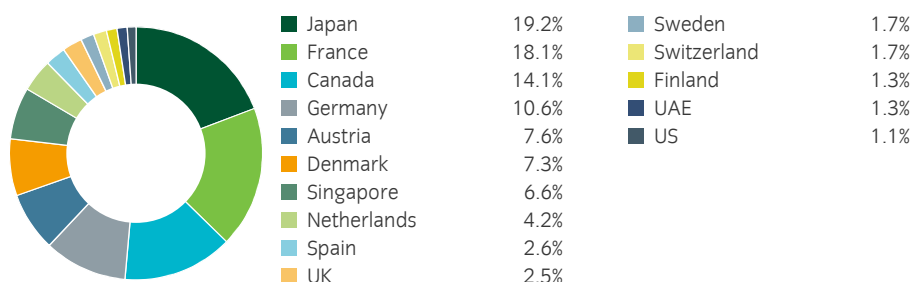

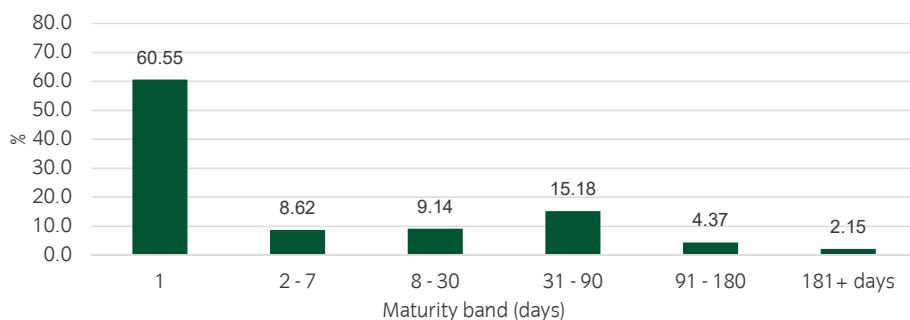

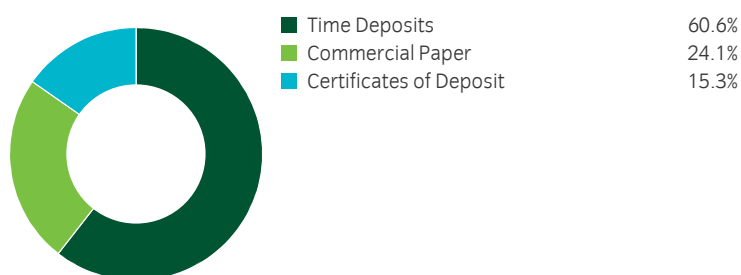
GEOGRAPHY
